

NIFTY (WEEKLY)



The Week That Went By:

Indian Market carry forwarded its consolidation phase. On the first day of the week Index oscillated in a narrow range. In the mid-week, Business at D-Street remained on a flat note with a negative bias but on every decline, Index found trend line and 100DMA support and recovered from the lower levels. On the last day of the week, after the strong opening, Index failed to hold higher levels and continued to loose its gains. In the last session, sharp fall was seen across the board especially in Media stocks which then dragged Index further lower.

MARKET OUTLOOK

From the past 9 weeks, Benchmark Index is oscillating in the range of 10520-10940. IT sector has given a breakout from a range but with a weak candlestick formation. Auto sector has given a breakdown from a flag and pole pattern which indicates further weakness in the sector. As upcoming week will be an expiry week along with the budget event, volatility is likely to persist.

Nifty has immediate resistance of 10950. On the downside 10715 hold as an immediate support. Bank Nifty has a stiff resistance of 27460 whereas support is placed around 27070 & 26450.

SECTORAL GAINER



Energy sector continued its outperformance as sector ended the week with a gain over 2% and outperformed Major Indices. Reliance Industries outperformed Index and sector with a return of 5.20%. Other components such as GAIL, BPCL ended the week with some gains. On the other side, RelInfra(9.25%) and PowerGrid(4%) were the underperformers. As mentioned earlier, sector has given a breakout from an ascending triangle pattern which is now confirmed with MACD buy signal.

SECTORAL LOSER



Media sector continued its outperformance as sector ended the week with a massive cut over (17%). 50% Heavyweight stock i.e. ZEEL was the worst performer as stock price corrected over (27%). Deep cut was seen in DishTV also as counter ended the week with a loss of (33.43%). Sector has given a breakdown from the continuation pattern pennant; target of the pattern has already achieved.
